Charges for Home Delivery Orders:

Please note that delivery charges are determined at checkout and constitute the final fees for delivering goods to the customer or Independent Distributor. We maintain standard delivery charges for most addresses.

For shipping within India:

A flat rate of Rs. 80.00/- applies to all orders below Rs. 1000.00/-Orders between Rs. 1000.00/- to Rs. 4999.00/- incur a charge of Rs. 140.00/-Orders between Rs. 5000.00/- to Rs. 9999.00/- incur a charge of Rs. 180.00/-Orders above Rs. 10000.00/- are subject to a delivery charge of Rs. 220.00/-Please note that delivery charges will be added to the purchase amount and collected accordingly.

The shipments are in perfect condition when the carrier takes possession of the same. By signing "received" on the delivery note, the recipient(s) acknowledges that the order was received in satisfactory condition. Do not sign in the event of damages or product shortages. Hidden damages discovered after the carrier has left and all other discrepancies must be notified within twenty-four (24) hours of receipt of shipment. Failure to notifyCSM Universefor any shipping discrepancy or damage within twenty-four (24) hours of receipt of the shipment will cancelCustomer / Independent Distributor(s)right to request a correction and shall be considered deemed acceptance of the products.



Orders placed are typically shipped the very next business day. Orders placed on Saturday after 2.30 pm will be shipped on the following Monday. Delivery time will vary according to the location of Customer/Independent Distributor(s). The average time for delivery is between 2 - 7 days. Delivery of products may not happen on Sundays or on major holidays as per the policy of the delivery partner.

Delivery of the Product

- There are various delivery models for delivery of purchased product to the . Customers/Independent Distributors, as decided by CSM Universe. - Customer/Independent Distributorshipping address; pin code will be verified with the database of
 website before they proceed to pay for their purchase. In the event order is not serviceable by
 logistic service providers or the delivery address is not located in an area that is covered under the
 order confirmation form, Customers/Independent Distributorsmay provide an alternate shipping
 address on which the Product can be delivered by the logistics service provider.
- Please note that there is no guaranteed dispatch time and any information about the dispatch should not be relied upon as such. Therefore, time is not the essence of the bi-partite contract between the Customers/Independent Distributorsand CSM Universefor purchase and sale of product on or through the Website: <u>www.csmuniverse.com</u>orhowever, the product shall not be delivered to theCustomer/ Independent Distributorunless he / she makes the full and final payment for CSMProducts.
- Customer/Independent Distributorshall be bound to take delivery of the Products purchased by him / her that are said to be in a deliverable state. Where Customer/Independent Distributorneglects or refuses to accept the delivery of the Products ordered by him / her, the Customer/Independent Distributormay be liable to CSM Universefor such non-acceptance.CSM Universeat its own discretion may call up the Customer/Independent Distributorto evaluate the reason of non-acceptance of the product. The decision ofIndependent Distributorwould be final and binding on whether to redeliver or process refund as per the refund policy.
- The title in the products and other rights and interest in the products shall directly pass on to the Customer/Independent Distributorfrom CSM Universeupon delivery of such Product and upon full payment of price of the Product. Upon delivery, theCustomer/Independent Distributorare deemed to have accepted the Products. The risk of loss shall pass on to the Customer/Independent Distributorupon delivery of Product.
- Before accepting delivery of any Product, the Customer/Independent Distributorshall reasonably ensure that the Product's packaging is not damaged or tampered.

Governing Law

Any dispute(s) between Customer/ Independent Distributoror its nominee(s) and CSM Universe, arising from this Policy, shall be referred to the sole arbitrator (appointed by CSM Universe) and same shall be adjudicated by such Arbitrator as per provisions of Arbitration Conciliation Act, 1996. However, all proceedings shall come within the jurisdiction of District Courts inKochi (Kerala, India)only and such arbitration proceedings shall be held in district courts ofKochi (Kerala, India)only. The final decision of the Arbitrator would be binding upon both the parties. Any breach



of this covenant by the Customer/Independent Distributorwill make him liable for damages and legal costs to CSM Universe.
